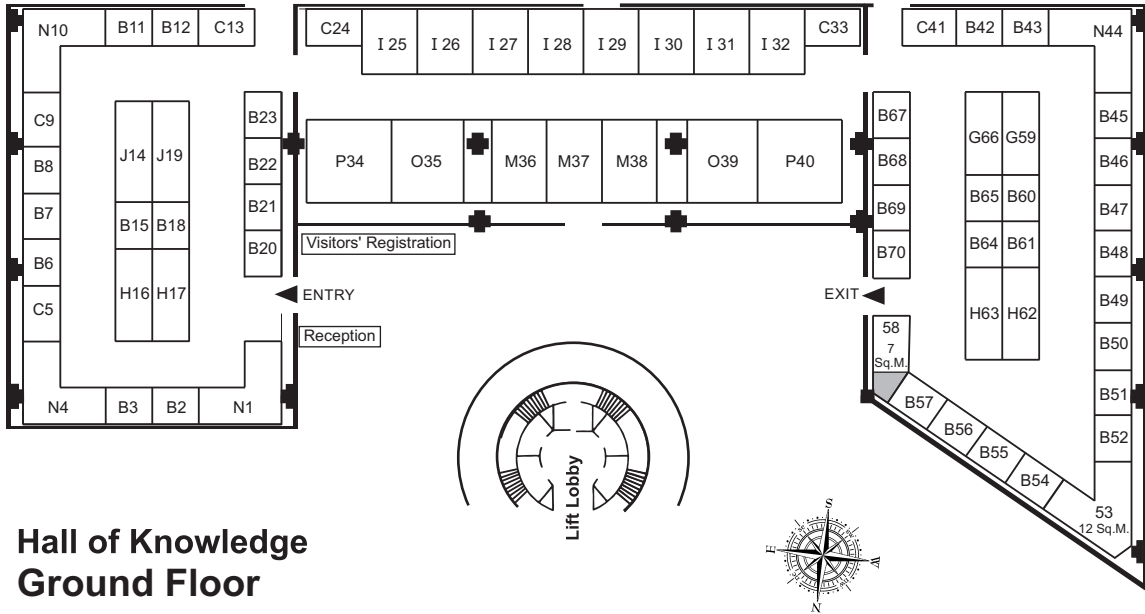
Terms and Conditions

(For Indian Participants)

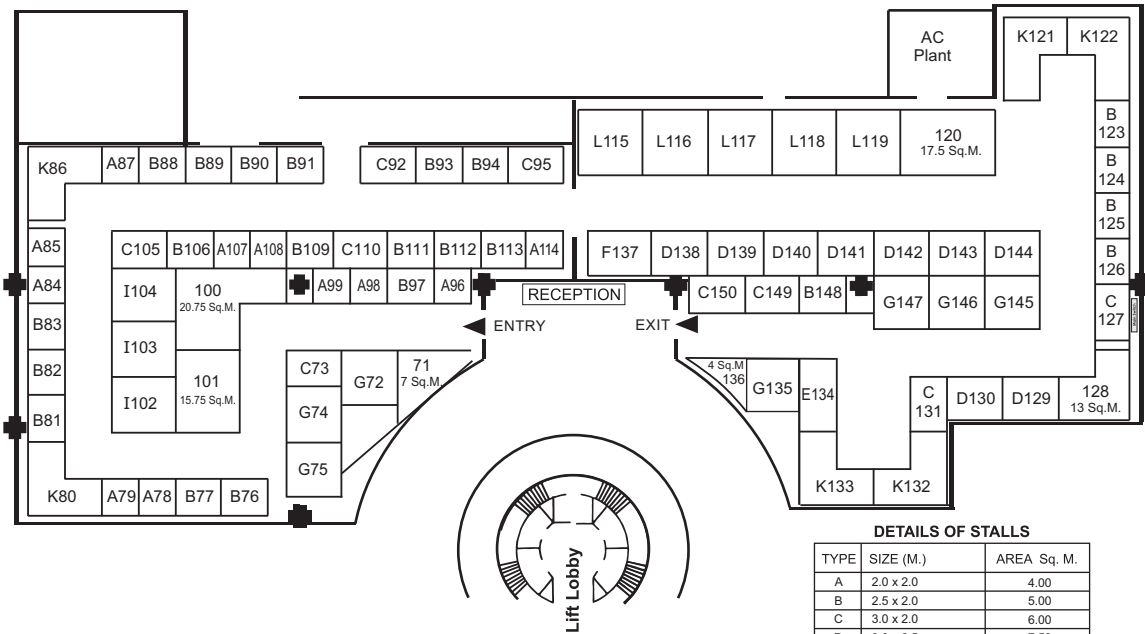

5. Any or all legal disputes will be strictly restricted to the jurisdiction of courts in Mumbai, India, alone.
